




The median income within Halton households in 2020 was \$121,000, up 17% from \$103,000 in 2015. At \$128,000, household median incomes were highest within the Town of Oakville. Across Halton, 60% of households had a total income of \$100,000 or more in 2020. Among Census Divisions within the Greater Toronto and Hamilton areas (GTHA), Halton reported the highest median household incomes in both 2015 and again in 2020.

Median household income between 2015 and 2020 across the Greater Toronto and Hamilton Area (GTHA)






\$58,000 – Median individual income among males in Halton in 2020 (+9% since 2015)

\$42,000 – Median individual income among females in Halton in 2020 (+20% since 2015)

The median income among individuals living in Halton in 2020 was \$48,400, up 14% from approximately \$42,500 in 2015. At \$58,000, individual income among men was 32% higher than women's median individual income which stood at \$42,000 in 2020. Across Halton, the highest individual incomes were reported within the City of Burlington at \$49,600. Among Census Divisions within the Greater Toronto and Hamilton areas (GTHA), Halton reported the highest median individual incomes in both 2015 and again in 2020 as well as the highest level of individual income obtained from employment sources.

Median income obtained through employment in 2020 across the Greater Toronto and Hamilton Area (GTHA)







Total number of census families in private households in 2016 and 2021 (with % change since 2016)





Since 2006, the growth rate of common-law relationships has out-paced marriages. However, married couples continue to represent the highest proportion of Halton's population aged 15+ (58% in 2006 and 55% in 2021). The proportion of Halton's population 15+ that were single in 2021 was 38%.

Milton saw the highest growth of families settling into households within Halton, representing an 18% increase in the past 5 years.

Nearly half of households within Halton had children in 2021, 39% of which consisted of a couple with kids. One in five Halton households consisted of persons living alone.

Information presented in this infographic is based on the Statistics Canada 2021 Census and previous Census years. Statistics Canada conducts a national Census of Population every five years. Statistics Canada will be releasing Census findings throughout 2022 in a series of seven data releases. Definitions: Median income of a specified group is the amount that divides the income distribution of that group into two halves, i.e., the incomes of half of the units in that group are below the median, while those of the other half are above the median. Median incomes of households are calculated for all units, whether or not they had income. Total income refers to the sum of certain incomes (in cash and, in some circumstances, in kind) of the statistical unit during a specified reference period. Employment income refers to all income received as wages, salaries and commissions from paid employment and net self-employment income from farm or non-farm unincorporated business and/or professional practice during the reference period. For the 2021 Census, the reference period for income data is the calendar year 2020, unless otherwise specified. A census family is defined as a married couple (with or without children), a common-law couple (with or without children) or a one-parent family. Source: Statistics Canada.
