

Niagara Escarpment Plan Amendment (NEPA) and Niagara Escarpment Development Permit – Approval authority: Niagara Escarpment Commission (NEC) under the *Niagara Escarpment Planning and Development Act* (*NEPDA*)

Regional Official Plan Amendment (ROPA) – Approval authority: Halton Region under the *Planning Act*

Local Official Plan Amendment (LOPA) – Approval Authority: City of Burlington under the *Planning Act*

Applications Received

- Applications were received by the Halton Region, City of Burlington on May 14, 2020
 - ROPA Application was deemed complete by Halton Region on July 20, 2020
 - LOPA Application was deemed complete by the City of Burlington on July 20, 2020
- NEPA and the NEC Development Permit applications were received by the NEC on May 14, 2020
 - NEPA was accepted for consideration and processing by the NEC on August 20, 2020
- ARA Licence Application received by MNRF on May 14, 2020
 - Application was deemed complete on October 5, 2020
- No decisions on any applications at this time

Agency Next Steps

- Technical review by JART staff and retained consultants underway
- ERO posting under the NEPDA early Q1 2021
- Statutory public meeting under the *Planning Act* joint Halton/Burlington meeting, early 2021
- Further technical review ongoing throughout this time
